- It pleases me to announce to you that **Jamie Cahn** has been named the program and events coordinator for a term that begins January 1, 2026. Jamie has a long history of serving as a

volunteer USA Swimming official and a commitment to athletes and coaches that began over 30 years ago.

Within that time, Jamie served his Maryland Swimming Local Swim Committee (LSC) as a Board of Directors member where he performed the duties of the vice-chair of finance and became a member of the Maryland Officials Committee, collectively spanning 20 years of dedication. Not only was he a critical member of Maryland LSC governance, but Jamie was also selected to be a part of the National Officials Committee where he oversaw the development of what we now recognize as the LSC Officials Chairs Quarterly Calls.

Jamie has achieved remarkable heights across many aspects of officiating. He has been a meet referee at every level of USA Swimming, including the 2024 U.S. Olympic Team Trials - Swimming, his fifth Olympic Trials (2008-ST, 2012-ST, 2016-CJ, 2021-DR, 2024-MR). - **National Meets:** Applications to officiate at national meets are generally posted six months (~180 days) prior to the meet start date. Applications typically close four months (~120 days) prior to the meet start date, but applications may close earlier if a sufficient number of applications have been received.
 - **TYR Pro Swim Series:** The Sacramento and Indianapolis TYR Pro meets will be considered as a group of two – officials may apply to both, but depending upon the applicant pool, may only be selected to work one of the meets. See “On the Horizon” below for information on how these two meets will be officiated.

The Officials' Excellence Award:

- National recognition for outstanding officials for LSC contribution
- Anyone can submit, although we will ask the LSC Officials' Chair or LSC General Chair for input
- The nominee must be an active member of USA Swimming with current registration
- There are six awards each year, one each in odd-numbered months
- Nominations close around April
- Nominations are held for two cycles (24 months) unless selected
- The National Officials Committee votes in May for the July through next May period (1 cycle)

Hopefully, your LSC OC committee is actively looking for ways to acknowledge officials and appreciate their service at the local level. This award is just a way to further acknowledge those deserving higher recognition. The link for the nomination form is [here](#).
