5. OMR Links – Eric

Need to discuss when to turn off offerings for 2024-25; do you want HQ to do it, or leave it up to the LSCs? We do not want to get in the same position we did last year and have over 1,000 refunds.

- When do we turn them off? August 1? Some clubs have already turned off their offerings.
- Need a communication to all LSCs that HQ will turn off all offerings on August 1. LSCs email their clubs to let them know. The LSC can turn on offerings as needed.

- Include bulk renewal notice to clubs, which has been turned on. It is on the Dashboard notifications.
- Moriah and Susan will put together the bulk renewal notice, and the offerings notice, and we will send it out.
- The email will include a request to see what the LSCs would like to be presented. Susan will draft a Google form to be included in the email.

6. USA Swimming Annual Summit – Angela/Eric/Denise

A working document has been shared with the committee, and it has been updated. The following was discussed to be presented:
