

Technical Release Notes October 22, 2024

New Features/Bugs Fixed

- Reporting
 - Club/LSC Reporting Refactor complete (mostly impacting speed and some functionality).
 - All SSRP reports have been refactored and redeployed
 - SSRP Stats
 - SSRP Current Status report
 - SSRP History report
 - IM is now included in the National Times Progression Dashboard
 - Meet Count by Athlete Reports have been consolidated into one report
- Members/Clubs/OMR
 - Member Requirement Alerts have been moved to the new email notification template
 - Includes APT 18 Year old Birthday alert
 - Includes APT 30/60 day alert for 17 year olds
 - Includes Background check alert during one's expiring month
 - Includes 30 day alert for all other member requirements
 - Includes 30 day alert for grace period for Rules & Regulations, CPR (For Junior Coach), and CORE Certification
 - Apprentice in Good Standing has been updated (cards will now show as being in Good Standing through the first 60 days)
 - New Club Application payment has been moved to the end of the process, after both the LSC and USA Swimming have approved the club
 - A Cart Item will be created, and a notification will be sent.
 - SRP Athlete Education measure now includes the Kids course (Ages 5-12) in the calculation
 - 2023 Members can now one-button renew

- Single meet offering has been removed from one-button renew options
- Fix to third party registration that allowed duplicate premium selections
- New popup modal in Member Info and OMR when someone changes Citizenship status
- Member cards for upgraded memberships are now hidden (Administrators that upgraded to Coach, Official, or Other will no longer see their prior Administrators card).
- Times/Meets/OME/Lane Sheets/NCAA
 - Bonus Time Standards can now be added to an existing Time Standard
 - Logos can now be uploaded for Time Standards
 - Bad Times Removal automated process now includes relays
 - Times Error tank process is now wrapped in a transaction to ensure everything completes
 - Mixed relays are no longer defaulting to Female category if there are 3 of one gender
- Officials Tracking System
 - National Certification Application is ready
 - This allows an official to request multiple position certifications at once
 - The official will receive an email notification after submitting
 - National Certification Approval Workflow is ready
 - Workflow includes private notes and public notes
 - Allows admin to override dates and add additional position certifications
 - Updates have been made to ensure certification dates stay continuous
 - LSC Certification sessions now have AR meet roles mapping to the Referee certification
 - LSC Bulk Recertification
 - New column that tracks completed tests and clinics

- New text to ensure the LSC Officials chair recertifies the highest certification level first
 - New logic to ensure that all children certifications get updated in a higher certification date is updated (EX: a change in SR dates updates ST dates)
- Reporting Updates
 - New report for NOC to track monthly/yearly applications, approvals, and denied applications
 - New LSC OTS Membership report with certifications
 - New LSC OTS report that shows all session counts
 - New Date Parameter in LSC Full Official History report
 - New OTS Meet Detail report that has all meet session details
 - New LSC Official Meet Type Attendance Report
 - Updates to National Meet Type Attendance Report
 - Evaluation Recommendation now included on Official History Report
- Data Hub
 - Block Party meets have been added to VCC
 - VCC Dashboard has been fixed to include all clubs
- Mobile App
 - Mobile App will include dynamically updated Time Standards once it gets approved in the App Store
- Misc
 - Permissions Updates
 - My Club will no longer show up prior to a new club being approved
 - Non-Approved new clubs no longer have access to Bulk Certification Purchase, My Club, or Club Renewal prior to getting approved
 - Automated permissions process will now remove Coach roles for people not registered as a coach
 - Swimming World text on payments page has been updated
